**Early Bird Seasonal Pass includes:** Adult/Senior seasonal pass holders will receive two free single use guest passes and Family seasonal pass holders will receive four free single use daily passes.

**All Season pass holders** will have one hour early admission to family swim & free access to after hour theme nights

**Racine Family YMCA members seasonal pass**

**General Public Seasonal Pass**

- Must be a Racine County resident to receive the Racine County resident rate, a drivers license must be presented to receive resident rate
- Seasonal pass holder (general public) are eligible for a \$10 discount on Pritchard Park Swim Lessons

**Children 7 & under** are required to be directly supervised at all times by a supervising adult.

- Children under 3 must be in the water within arm's reach of a supervising adult
- Children 4-7 must be in the water with an adult, take a swim test and stay in area defined by colored wristband

**Children 8-11** are required to be accompanied by a supervising adult who remains in the waterpark, take a swim test & stay in areas defined by color wristband

- Everyone entering the facility must have a Seasonal Pass or purchase a day pass.
- A picture ID must be presented when purchasing all passes.
- Racine County Residents must have a Racine County ID to receive the resident rate.
- A waiver must be on file for all day pass swimmers, including an emergency contact.
- Waivers for minors must be signed by an adult.
- All code of conduct & supervision policies must be followed.

**All Seasonal Passes are non-refundable and expire September 6, 2021**
