Supervision Guidelines

Children 7 & under are required to be directly supervised at all times by a supervising adult.

- Children under 3 must be within arms reach of supervising adult
- Children 4-7 must be in the water with an adult, take a swim test and stay in area defined by colored wristband

Children 8-11 are required to be accompanied by a supervising adult who remains in the waterpark, take a swim test and stay in areas defined by colored wristband.

Children 12 & up are not required to be accompanied by a supervising adult, take a swim test and stay in areas defined by colored wristband.

- Racine Family YMCA members seasonal pass upgrade ***
- This is an add-on pass for current Racine Family YMCA members ONLY
 - Must be a current Racine Family YMCA member for the entire season
 - Nationwide Y members are not eligible for upgrade
 - Upgrade must be completed at the Lakefront – Sealed Air branches

- General Public Seasonal Pass ****
- A drivers license must be present when purchasing seasonal & daily pass
 - Must be a Racine County resident to receive the Racine County resident rate
 - Seasonal pass holder (general public) are eligible for a \$10 discount on Pritchard Park Swim Lesson

- Terms & Conditions**
- General Public Seasonal Pass does not include access to the Racine Family YMCA branches.
 - Seasonal Passes are non-refundable – no refunds will be issued after the start of the season.
 - Racine Family YMCA is not responsible for lost or stolen passes, passes may be replaced for \$5 per card.
 - A season pass must be swiped at the Welcome Desk to enter the Aquatic Center or a daily fee apply – passes expire September 2, 2019.
 - Racine Family YMCA is not responsible for loss or damage of valuable or property of members or guests.
